### 2 INTRODUCTION

### 3 USER GUIDE

The following is a description of each column used in the overview table in section 4 below:

- (i) **Document ID**: Is the identification number of the document.
- (ii) **Document title**: Is the current name of the document.
- (iii) **Distribution**: There are three different distribution categories
  - a. Red which mean no distribution of the document to external parties.
  - b. Yellow which mean that distribution of the document to external parties could be considered.
  - c. Green which mean unrestricted distribution of the document to external parties.
- (iv) **Status**: There are three different status categories:
  - a. Red which mean that the document is not in use.
  - b. Yellow which mean that the document is a draft which is currently under development, so changes can occur.
  - c. Green which mean that the document is the current applicable version.
- (v) **Publicised:** The input for this column is either 'Yes' or 'No'. If 'Yes' the document has been published and can be regarded as the governing document. If 'No' the document is a draft.

- (vi) **Approved version:** Used for keeping track of latest updates in terms of date for latest change and the current version number.
